- Creates an Office of Tribal Government Affairs
- Originally led by a Deputy Assistant Secretary
- Elevates leadership to Assistant Secretary
- OTGA has been funded by omnibus (Sr Tribal Affairs Advisor)

DOT Tribal Consultation Policy

- Initially put our for Tribal Consultation via POTUS Memorandum 1.26.2021
- Comments adjudicated and put back out for Tribal Consultation 1.31.2022
- Virtual consultation held 4.27.2022
- Comment period closed May 31st, 2022
- Once finished DOT will begin developing policy to work with Native Hawaiians.

Tribal Transportation Self Governance Program

The purpose of the TTSGP is to provide Tribes and Tribal organizations with greater autonomy, control, flexibility, and decision-making authority over federal transportation funds used to carry out tribal transportation programs and activities in tribal communities.

- Section 1121 of the FAST Act (23 U.S.C. § 207)
- Negotiated rulemaking with Tribes
- Final Rule published on June 1, 2020 (49 C.F.R. part 29)
- Final Rule effective date October 1, 2020
